The purpose of this modification is to (1) provide incremental funding in the amount of \$99,921.72 in support of the base year; and (2) exercise Option Year One (CLIN 0002). This modification fully funds the base year and increases the total value of the contract to \$398,824.80. The period of performance is hereby extended through September 30, 2008. Funding in support of the Option Period Two is currently not available and is subject to FAR 52.232-18.
