This is in reference to your application dated October 3, 2007, requesting to amend Nuclear Regulatory Commission License No. 19-0294-19. In order to continue our review, we need the following additional 00294 information:

- 1. Your amendment request did not include procedures for use of fixed gauges at temporary job sites. Please state that, "Procedures for use of fixed gauges at temporary job sites will be developed, implemented, maintained, and distributed and will meet the Criteria in the section entitled 'Radiation Safety Program - Fixed Gauges Used at Temporary Job Sites,' in NUREG-1556, Vol. 4, 'Consolidated Guidance about Materials Licenses: Program-Specific Guidance about Fixed Gauge Licenses, dated October 1998 and copies of these procedures will be provided to all gauge users." OR Submit alternative procedures for use of fixed gauges at temporary job sites.
- 2. You have included a Statement of Intent to update your financial assurance requirements. However the other documentation is needed as stated in NUREG-1757 Volume 3, Consolidated NMSS Decommissioning Guidance Financial Assurance, Recordkeeping, and Timeliness. Please submit a Certification of Financial Assurance (CFA) and a Decommissioning Funding Plan (DFP). The appropriate level of detail for the CFA is discussed in Appendix A.2. The DFP must include an actual estimate of the costs for decommissioning your facility. The appropriate level of detail for the cost estimate is discussed in Appendix A.3 to Volume 3 of NUREG-1757, "Consolidated NMSS Decommissioning Guidance."
