SUBJECT: NOTICE OF VIOLATION (NRC INSPECTION REPORT NOS. 50-390/94-53, 50-391/94-53)

Gentlemen:

This refers to the NRC inspection of the implementation of the Cable and Electrical Issues Corrective Action Programs (CAP) conducted by J. F. Lara on July 18 through 22 and August 1 through 5, 1994. The inspection included a review of activities authorized for your Watts Bar facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

The inspection focused on the verification that the completed corrective actions were adequately implemented in accordance with the approved CAPs. Particular emphasis was placed on the field verification of those completed activities. Areas examined during the inspection are identified in the enclosed report. Within these areas, the inspection consisted of selective examinations of electrical system calculations, work implementing documents, procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). In addition, the enclosed Inspection Report identifies Watts Bar Unit 2 activities that violated NRC requirements that will not be subject to enforcement action because your efforts in correcting the violation meet the criteria specified in Section VII.B of the Enforcement Policy.

Although significant progress has been made in the implementation of the CAP corrective actions, this was overshadowed by the inadequate implementation of corrective actions in some of the technical areas. The overall inspection findings for both CAPs indicate general problems in the area of electrical system and component modifications. Because the problems were identified in these highly visible, comprehensive corrective action programs, it is of concern that similar problems may exist in other non-CAP associated electrical system modifications. Your corrective actions to address the identified deficiencies and concerns should focus on ensuring not only that the identified deficiencies are adequately resolved but also that corrective actions for other non-CAP electrical system problem areas are adequately implemented.
