On July 27, 2007 the Pressurized Water Reactor Owners Group (PWROG) submitted WCAP-15830-P/NP, Rev 1, "Staggered Integrated ESF and LOOP Surveillance Testing at CE NSSS Plants" for staff review and approval (Reference 1). As discussed during the September 5, 2007 meeting between the NRC Staff and the teleconference on September 27, 2007, the NRC Staff requested that the PWROG provide a comparison of the changes made between Revision 0 and Revision 1 of WCAP-15830-P. Please find enclosed the requested comparison document. This comparison document begins with a high level summary of the changes between Revision 0 and Revision 1 followed by a specific comparison of the changes from Revision 0 to Revision 1. Text that was deleted from Revision 0 is shown as crossed-out or strikethrough (~~deleted~~) and text that was added to Revision 1 is shown as underlined (underlined).

Appendix A which contained the risk analysis for Calvert Cliffs has been removed from Revision 1 since Calvert Cliffs decided to withdraw from this effort at this time. The risk analyses contained in Appendices B and D were updated from Revision 0 to Revision 1 as shown in the comparison document along with other global changes made to Appendices B, C and D. Appendix C is not included in the comparison document since the risk analysis was not updated and the only changes made from Revision 0 to Revision 1 for Appendix C were the same global changes made and already identified in the Revision 0 to Revision 1 comparison for Appendices B and D.


