



The last sentence of page 2-17 of the "Safety Evaluation of the Watts Bar Nuclear Plant Units 1 and 2," was revised at the construction permit hearing to read, "We have informed the applicant that we will require the results of these investigations and related facility design information to be submitted to us for our review and approval prior to the commencement of work on soil-based structures, namely the diesel generator building and the intake channel." Accordingly submitted herewith is Amendment 22 to the TVA application for units 1 and 2 of the Watts Bar Nuclear Plant. This amendment consists of a new appendix, "Watts Bar Nuclear Plant Soil Investigation Program Conducted in 1972," and miscellaneous page revisions.

Please note this is not a request to amend our construction permits and does not present a significant hazards consideration. Accordingly, a notice of hearing is not required.

Instructions for incorporating the amendment into the PSAR are included with the amendment.



INSTRUCTIONS FOR AMENDMENT TWENTY-TWO PAGE CHANGES

The following instructional information and check list is furnished to help you insert Amendment Number Twenty-two into the Watts Bar Nuclear Plant PSAR.

Since in most cases the original PSAR contains information printed on both sides of a sheet of loose leaf paper, a new sheet is furnished to replace sheets containing superseded material. As a result, the front or back of a sheet may contain information that is merely reprinted rather than changed.

Only pages which contain amended (i.e., added, deleted, or revised) information are identified with the cipher "WBNP-22" at the top of the page. Further, where amended information is new or revised, a vertical bar has been inscribed adjacent to the information in the outside margin of the page.

Discard the old sheets and insert the new sheets, as listed below. Keep these instruction sheets in the front of Volume I to serve as a record of changes.
