Previously, operating rooms 1 through 8 were identified as areas of use. All OR rooms will be considered as controlled areas on days of use in which Nuclear Medicine procedures are performed in that room. On those days of use, after the room has been area surveyed and wipe tested, the room may be released, thus becoming an uncontrolled area. All rooms adjacent to a room undergoing a nuclear medicine procedure shall be considered as an uncontrolled area.




