ORDER

(Adopting Transcript Corrections)

Before the Licensing Board in the above captioned proceeding are motions submitted by Citizens,¹ AmerGen Energy Company, LLC, and the NRC Staff requesting that certain corrections be made to the transcripts of the September 24 and September 25, 2007 evidentiary hearing sessions conducted in this proceeding in Toms River, New Jersey.
