IF YOU DESIRE TO CONTINUE YOUR RADIOISOTOPE PROGRAM, AN APPLICATION FOR RENEWAL OF THE LICENSE SHOULD BE FILED WITH THIS OFFICE.

RENEWAL APPLICATIONS SHOULD BE FILED ON THE ENCLOSED FORM NRC-313, APPROPRIATELY SUPPLEMENTED, AND SHOULD CONTAIN COMPLETE AND UP-TO-DATE INFORMATION ABOUT THE APPLICANT'S CURRENT PROGRAM.

IN ORDER TO FACILITATE THE REVIEW PROCESS, THE APPLICATION FOR RENEWAL SHOULD BE SUBMITTED WITHOUT REFERENCE TO PREVIOUSLY SUBMITTED DOCUMENTS AND INFORMATION. IF SUCH REFERENCES CANNOT BE AVOIDED, THEY SHOULD BE CLEAR AND SPECIFIC AND SHOULD IDENTIFY THE PERTINENT INFORMATION DATE, PAGE, AND PARAGRAPH.

IT IS TO YOUR ADVANTAGE TO FILE SUCH AN APPLICATION AT LEAST THIRTY (30) DAYS BEFORE THE EXPIRATION DATE OF YOUR EXISTING LICENSE. YOUR PROGRAM WILL THEN BE COVERED BY YOUR EXISTING LICENSE UNTIL ACTION IS TAKEN ON YOUR APPLICATION FOR LICENSE RENEWAL (SECTION 50.37(B)). IF AN APPLICATION IS RECEIVED LESS THAN 30 DAYS PRIOR TO THE EXPIRATION DATE OF YOUR LICENSE AND CANNOT BE PROCESSED BEFORE YOUR EXISTING LICENSE EXPIRES, THIS COULD RESULT IN YOUR POSSESSING RADIOISOTOPES WITHOUT A VALID LICENSE.

IF YOU DO NOT WISH TO RENEW THE LICENSE, PLEASE COMPLETE ENCLOSED CERTIFICATE OF DISPOSITION OF MATERIALS (NRC-314), AND RETURN IT TO THIS OFFICE.
