We installed overburden wells at Clusters -09 and -10. The overburden well at cluster -09 was in addition to the two bedrock wells installed at that location. At cluster -10, one bedrock well and one overburden well was installed. We are planning on installing an overburden well at the -06 cluster based on the conditions observed while installing the bedrock wells at that location. As stated in the FSP Addendum 4, during the installation of the remainder of the well clusters we will continue to evaluate the overburden materials for the presence of saturated permeable materials and consider installation of wells with screened intervals in the unconsolidated materials.
