Hospital (License No. 37-17886-01 Amendment No. 14)

Dear Ms. Weidner:

In accordance with 10 C.F.R. §30.34(b), this letter is to notify the Licensing Assistance Section of the U.S. Nuclear Regulatory Commission (the "Section") that West Grove Hospital Corporation ("West Grove"), a Pennsylvania corporation that owns and operates Jennersville Regional Hospital (the "Hospital"). The purpose of this letter is to inform you of (1) a planned corporate restructuring (the "Corporate Restructuring") that will include (a) the conversion of West Grove from a corporation to a limited liability company, and (b) certain other changes to West Grove's parent ownership structure, and (2) the sale (the "Membership Interests Sale") of up to 27% of the interests in the limited liability company that will own the Hospital to physicians who are on the medical staff of the Hospital.

The conversion of West Grove will be effected by the merger of West Grove with and into West Grove Hospital Company, LLC, a Delaware limited liability company. West Grove Hospital Company, LLC will succeed to all of the assets and liabilities of West Grove, and as a result will be the owner and operator of the Hospital. Immediately following the merger, the West Grove Hospital Company, LLC will sell up to 27% of its membership interests to physicians on the medical staff of the Hospital. In connection with the change of ownership, the parties do not plan to effect any material changes in the radiation safety program previously conducted by the Hospital or in related facilities or personnel.

West Grove Hospital Corporation hereby consents to the transfer of the above-referenced materials license to West Grove Hospital Company, LLC in connection with the closing of the transaction described in this letter. Effective upon the closing of the conversion described above, West


