Dear Sir/Madam:

Please amend license SUB 831 to permit the transfer of all uranium and thorium source materials presently covered by license SMB 1005 to SUB831. The address on SUB 831 should be changed to General Electric Company, Space Systems Division, P. O. Box 8555, Philadelphia, PA 19101.

Also add the following new facility location to the list of authorized locations covered under SUB 831:

Concurrent with this amendment, we are requesting that license SMB 1005 be permitted to expire on May 31, 1985. The Allendale Road and Third Avenue, King of Prussia locations listed on SMB 1005 have not been used to handle source materials for some time and there are no planned uses at these facilities in the future. For this reason, we are not requesting that these authorized locations be transferred from SMB 1005 to SUB 831.

Re-Entry Systems Operation is now a part of Space Systems Division, and this consolidation of licenses is consistent with the action taken with our bi-product material licenses in 1984.

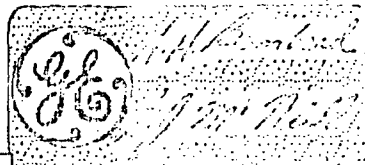

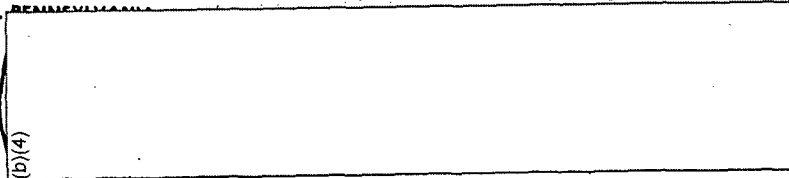
