ACTION: REVISION OF THE CHRONOLOGY OF NRC AMENDMENTS INCLUDING THE SUMMARY OF CHANGE DOCUMENT FOR NRC AMENDMENTS, EXEMPTIONS FROM LICENSING, AND DISTRIBUTION OF BYPRODUCT MATERIAL: LICENSING AND REPORTING REQUIREMENTS. [RATS ID 2007-2] (FSME-07-104)

Purpose: To Provide the Agreement States with the Chronology of the U.S. Nuclear Regulatory Commission (NRC) Amendments including the addition, RATS ID 2007-2 , Exemptions From Licensing, General Licenses, and Distribution of Byproduct Material: Licensing and Reporting Requirements (effective date December 17, 2007) and the Summary of Change Document.

Background: The NRC is amending several regulations governing the distribution of byproduct material in four sections in the Code of Federal Regulations (CFR). The final rules are posted in the Federal Register, 72 FR 58473 and can be accessed through this website: <http://www.gpoaccess.gov/fr/index.html>. The chronology is enclosed in its entirety and includes RATS ID: 2007-2, as maintained by the Office of Federal and State Materials and Environmental Management Programs (FSME). The chronology is for your use to plan rulemaking actions that are needed to satisfy the compatibility and health and safety category designations of the NRC regulations. This document will also be used by the Integrated Materials Performance Evaluation Program teams during upcoming program reviews. In addition, a summary of change for the December 17, 2007 amendments has been enclosed with this letter. These summaries are for your use to identify the changes to the CFR text as well as the compatibility categories associated with the changes. These regulations are due for adoption by the Agreement States no later than December 17, 2010.
