Gentlemen:

Public Law 91-560 enacted on December 19, 1970 amended the Atomic Energy Act of 1954, by eliminating the requirements that the Commission make "a finding in writing that any type of utilization or production facility has been sufficiently developed to be of practical value for industrial or commercial purposes" before the Commission may issue commercial licenses under §103 of the Act for such facilities. Public Law 91-560 states that utilization or production facilities for commercial or industrial purposes must be licensed under §103.

The Commission published in the Federal Register on December 29, 1970 certain amendments to Parts 2 and 50 of 10 CFR (copy enclosed) which contain provisions whereby an antitrust review will be conducted of all applications for §103 licenses. It is anticipated that for pending applications the information submitted to the Commission to establish financial qualifications under §50.33(f) will form an adequate basis on which to start antitrust review. In connection with this review, however, it is recommended that you submit financial information to us as it becomes current.

In accordance with the revisions to §50.33(1), please submit to us as soon as possible a list of the names and addresses of such regulatory agencies as may have jurisdiction over the rates and services incident to the proposed activity, and a list of trade journals and newspapers which circulate in the area where the proposed activity will be conducted and which are considered appropriate to give reasonable notice of the activity to the local municipalities, private establishments, public bodies, and cooperatives which might have an interest in the facility. The Commission has selected Public Power, Electric Light and Power,


