SUBJECT: SUMMARY OF WATTS BAR MEETING ON JUNE 22, 1978

A meeting was held in Bethesda, Maryland with representatives from TVA to discuss a list of requests for information in the area of instrumentation and controls. The request for information had been previously provided, informally, to TVA in preparation for the meeting. A list of attendees is enclosed.

At the outset, TVA expressed concern over the untimely, lengthy list of requests for information that was being asked at this stage of the review. The FSAR was docketed in October 1976, and the review is generally at the stage where the staff is establishing positions in the various technical areas. In the opinion of the applicant approximately 50% of the listed items are appropriate, and the remaining items fall into these categories: technically inappropriate, ill-defined, new issues, overlapping requests, and typical questions within the purview of the office of Inspection and Enforcement. The discussions for the meeting, therefore, were on the aforementioned categories of items that were identified by TVA. In response to the lateness of these requests for information, the delay was due to a change in the assigned technical reviewer from Instrumentation and Controls Systems Branch. The first reviewer accepted another position.

The results of the meeting were that approximately 20 items from an initial TVA listing of 95 items would be withheld pending further review by the staff. All other requests would be forwarded to TVA for formal responses in order to minimize any delays. Further discussions may be required to resolve the appropriateness of the withheld issues, depending on the outcome of our review.


