On January 26, 1977 I wrote to you indicating an interest by my clients, Safe Forms of Energy for Tennessee (SAFE-T), in filing a petition to intervene in the proceeding to review the application of the Tennessee Valley Authority for operating licences for the Watts Bar Nuclear Plant. At that time I requested an extension of time in which to file a petition to intervene.

After reviewing finances and the amount of time which an intervention would require, we have decided that we will be unable to proceed with plans to intervene.
