

The purpose of this modification is to provide incremental funding in the amount of \$10,000.00, revise FAR clause 52.232-19 - Availability of Funds for the Next Fiscal Year (Apr 1984), and revise Section A.3 Consideration and Obligation - Delivery Orders (Jun 1988).

The purpose of this modification is to:

1. Provide incremental funding in the amount of \$10,000.00
2. Revise FAR clause 52.232-19 – Availability of Funds for the Next Fiscal Year (Apr 1984)
3. Revise section A.3 Consideration and Obligation – Delivery Orders (Jun 1988)

Delivery Order DR-10-07-439 is hereby modified as follows:

1. Funds are hereby obligated in the amount of \$10,000.00. Funding is increased by \$10,000.00 from \$225,000.00 to 235,000.00.
2. FAR clause 52.232-19 – Availability of Funds for the Next Fiscal Year (Apr 1984) is hereby revised as follows:

Funds are not presently available for performance under this contract beyond the current funding amount of \$235,000.00 (This can be any combination of SZT-20-421-MA1 and M600-2100). The Government's obligation for performance of this contract beyond that quantity is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond the current funding amount of \$235,000.00 (This can be any combination of SZT-20-421-MA1 and M600-2100), until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.

3. Section A.3 Consideration and Obligation – Delivery Orders (Jun 1988), Part B, Sentence One (1) is hereby revised as follows:

“The amount presently obligated with respect to this contract is \$235,000.00.”

4. The following is a summary of NRC obligations from the date of award. The Contractor shall not exceed this obligated amount:
