WATTS BAR NUCLEAR PLANT (WBN) - EMPLOYEE CONCERNS SPECIAL PROGRAM (ECSP)

TVA is initiating the following actions for Watts Bar Unit 1. These actions will provide added assurance that the Corrective Action Plans (CAPs) associated with the Employee Concerns Special Program (ECSP) Corrective Action Tracking Documents (CARDs) are consistent with the currently planned resolution.

TVA will evaluate the latest approved CAPs for the remaining open WBN Unit 1 CATDs for which a closure package has not been prepared. If necessary, deviations will be prepared to assure consistency with the actions currently planned to resolve the employee concerns. The evaluations and deviations will be completed by September 30, 1994. Deviations will be processed in accordance with TVA Nuclear Power Standard (NP STD)-1.2.

TVA will also submit to the NRC a special report of the WBN Unit 1 1994 CAP deviations that are approved prior to September 30, 1994. The report will be submitted by October 31, 1994. The WBN Unit 1 special report of approved CAP deviations is intended as a supplement to the ECSP Sixth Annual Report which was transmitted to the Nuclear Regulatory Commission on April 28, 1994.
