Gentlemen:

The purpose of this letter is to inform you of the results of our review of your letter dated February 16, 1995, which provided the results of TVA's review of potential chilling effects at TVA. Our letter of April 25, 1995, stated that we would do this.

We have completed our review of your letter of February 16, 1995. In that correspondence you provided your rationale why there had been no "chilling effect" based on the compliant filed by Mr. Matthews with the Department of Labor. Your letter stated your belief that your, "...prompt and firm corrective actions effectively avoided any chilling effect, either site-wide or within the specific work group."

Our independent assessment, based on observations and discussions on site, does not contradict this conclusion. Accordingly, we do not find that a chilling effect resulted from the circumstances surrounding the Matthews case.
