SUMMARY
In our telephone conversation on this date, I related that the subject license was initially issued to Cancer Care Group, P.C., the license applicant. However, as noted in the copy you provided (with your letter dated August 24, 2007) of "Appendix F: Faxable Version of Information Needed for Transfer of Control Application" as quoted from NUREG-1556, Vol. 15, licensees must provide full information and obtain NRC's prior written consent before transferring control of the license. Please note that prior to our providing that written consent, the response to Appendix F, such as that provided in your letter dated August 24, 2007, must be signed by a high level management representative of the transferor and also signed by a high level management representative of the transferee. Please note that this conversation record, a copy of which is being sent to you by facsimile, will serve as our written consent, conditioned upon your providing the jointly signed document as described above. Also, please note that in your letter dated August 24, 2007, the reference to an attached surveillance program was not attached. Please provide or explain.
