Per our telephone conversation, I am supplementing my initial notice with the NUREG information. The conversion of West Grove will be effected by the merger of West Grove with and into West Grove Hospital Company, LLC, a Delaware limited liability company. West Grove Hospital Company, LLC will succeed to all of the assets and liabilities of West Grove, and as a result will be the owner and operator of the Hospital. Immediately following the merger, the West Grove Hospital Company, LLC will sell up to 27% of its membership interests to physicians on the medical staff of the Hospital. The name of the licensed organization will be West Grove Hospital Company, LLC.

In connection with the change of ownership, the parties do not plan to effect any material changes in the radiation safety program previously conducted by the Hospital or in related facilities or personnel. None of the facilities, equipment, or procedures will change. There are no planned changes in use, possession or storage of the licensed materials at the Site. All surveillance items and records are current and all inspections are up-to-date. The Hospital performs surveys, quality control, and weekly wipe tests as per the Nuclear Regulatory Commission regulations. The Hospital has inspected those areas of the Site that require inspection and determined that there is no radioactive contamination present at such areas that would require any further action..
