Lynch, Jr., of January 27, 1977, in which he arranged a meeting with your staff and that of the Nuclear Regulatory Commission to be held on February 25, 1977, at 2:00 p.m. in Room 106 of the Tennessee Wildlife Resources Agency, Ellington Agricultural Center.

As was indicated, we are reviewing the environmental aspects of operation of the Watts Bar Nuclear Plant, Units 1 and 2, presently under construction by the Tennessee Valley Authority (TVA). In this forthcoming meeting with you and your staff we are interested in discussing your agency's concerns regarding the operation of the Watts Bar facility so that they may be incorporated in our review and given appropriate consideration in the environmental statement.
