SUBJECT: WATTS BAR NUCLEAR PLANT REACTOR OPERATOR AND SENIOR
REACTOR OPERATOR LICENSE RENEWALS

In a telephone conversation between Mr. L. Pauley, Manager-Operator Training, and Mr. D. C. Payne, Senior License Examiner, arrangements were made for renewal of operator licenses currently being held at the Watts Bar Nuclear Plant. At your earliest convenience, it is requested that updated Personal Qualification Statements (NRC Form 398) and Certifications of Medical Examination (NRC Form 396) be submitted to Mr. Charles A. Casto, Chief, Operator Licensing Section 2, Region II.

Applicants that continue to meet the requirements of 10 CFR Part 55 will have their licenses renewed for six years from the effective date of the renewal. Those operators whose licenses are renewed will be expected to participate in your facility's Requalification Program and should be periodically examined for proficiency by your program. Arrangements for future NRC conducted routine exams will be coordinated with your staff.
