On December 14, 1993, NRC and TVA representatives met at the Watts Bar site to discuss the status, needed actions, priorities and schedules of various licensing issues. These include all unresolved outstanding issues, confirmatory issues, proposed license conditions, corrective action programs (CAPs), special programs (SPs), TVA's response to generic letters and bulletins. The discussion was based on the latest licensing status as published in the Watts Bar Safety Evaluation Report Supplement 12 (NUREG-0847, Supp. 12). The Office of Nuclear Reactor Regulation (NRR) issues the Safety Evaluation Report (NUREG-0847) and supplements (SSERs) as its principal licensing basis documents for Watts Bar. Section 1 of the latest SSER (SSER 12) officially documents the issues that NRR considers needing resolution before an operating license can be granted.

Enclosure 1 is the list of meeting participants and observer.

Schedular information regarding NRR reviews and other comments were exchanged with TVA personnel, agreed upon, and subsequently used to update the NRR staff's work control system, Workload Information and Scheduling Program (WISP). The output of WISP (Enclosure 2) records the staff's understanding of the status of each active NRR action.
