Dear Mr. Chavez:

I am responding to your undated letter, addressed to Mr. Roger Hannah, Public Affairs Officer of our Region II office. You requested, among other things, "to be added to our "service list for documents concerning TVA."

The Commission has made provisions for members of the public to obtain various forms of information. The enclosed "Citizen's Guide to U.S. Nuclear Regulatory Commission" (NUREG/BR-0010, Rev. 2), gives the needed information. Of special note are the local public document rooms (LPDRs) located near each nuclear plant, which are the Commission's primary vehicle for disseminating documents to the public. For example, the LPDR for the Sequoyah and Watts Bar Nuclear Plants is Chattanooga-Hamilton County Library, 1001 Broad Street, Chattanooga, Tennessee. You may obtain TVA documents by visiting the LPDR, or by contacting our LPDR staff at 1-800-638-8081.

Considering the availability of documents through numerous means, as well as the quantity of paper, and the clerical resources needed to comply with your request, we have determined that it is not practical to add your name to the TVA mail distribution, of which there are four lists, covering nine TVA nuclear units.
