JANE A. FLEMING 2.206 PETITION REGARDING WATTS BAR

NUCLEAR PLANT

Attached is a copy of a letter dated January 25, 1996, filed with the Chairman by Jane A. Fleming requesting that the NRC take action with regard to the low-power license for the Watts Bar Nuclear Plant. Specifically, Ms. Fleming requests that a full and impartial review of the entire Watts Bar licensing process be implemented, examining the implementation of the procedures of review used by the NRC and the validity of the information presented by the licensee, and that the low-power license for Watts Bar be suspended until such review is completed and the issues in dispute are resolved. Ms. Fleming suggests that the Chairman initiate her own review of the information provided, but states that if the Chairman does not choose to initiate her own review, the letter be considered under 10 C.F.R. § 2.206. Following review of the letter by OGC, it has been determined that the letter should be handled pursuant to section 2.206.

As a basis for her request, Ms. Fleming (Petitioner) asserts that the NRC staff was not fully aware of the licensee's commitments and compliance with these commitments when it issued the licensee a fuel load and low power license on November 9, 1995. Specifically, the Petitioner asserts that a letter from Stewart D. Ebneter, Regional Administrator, Region II, dated January 12, 1996, to Oliver Kingsley, TVA, which states that open issues regarding the radiation monitoring system for Watts Bar existed when TVA requested the operating license, raises a question as to the conclusion drawn by the NRC staff in the Supplemental Safety Evaluation Report issued in September 1995, that the system meets the acceptance criteria of the Standard Review Plan and is, therefore, acceptable.

I have attached a draft letter of acknowledgement to the Petitioner for your signature. I am also enclosing a Notice of Receipt of the Petition for publication in the Federal Register.

If you want the licensee to respond regarding these matters, we will assist your staff in drafting an appropriate letter. If you want more information from the Petitioner, we will be glad to assist your staff in drafting a letter requesting this information.
