Dear Ms. Weidner:

Per our telephone conversation, I am supplementing the initial notice with the NUREG information. The conversion of Northampton will be effected by the merger of Northampton with and into Northampton Hospital Company, LLC, a Delaware limited liability company. Northampton Hospital Company, LLC will succeed to all of the assets and liabilities of Northampton, and as a result will be the owner and operator of the Hospital. Immediately following the merger, the Northampton Hospital Company, LLC will sell up to 10% of its membership interests to physicians on the medical staff of the Hospital. The name of the licensed organization will be Northampton Hospital Company, LLC. The conversion is expected to take place on or after December 1, 2007.

In connection with the change of ownership, the parties do not plan to effect any material changes in the radiation safety program previously conducted by the Hospital or in related facilities or personnel. None of the facilities, equipment, or procedures will change. There are no planned changes in use, possession or storage of the licensed materials at the Site. All surveillance items and records are current and all inspections are up-to-date. The Hospital has inspected those areas of the Site that require inspection and determined that there is no radioactive contamination present at such areas that would require any further action. 


