This letter is in response to your submittal dated May 7, 2007, and supplemented on September 6, 2007, in which you requested the U.S. Nuclear Regulatory Commission (NRC) to review proposed changes to the Physical Security Plan and Safeguards. Contingency Plan for the San Onofre Nuclear Generating Station, Units 2 and 3 based on the demonstration of the general performance objective required under the provisions of paragraph 73.55(a) of Title 10 of the *Code of Federal Regulations* (10 CFR).

We have reviewed your proposed changes and find them acceptable in meeting the general performance objective described in 73.55(a). The changes described do not decrease the effectiveness of the security plan, and may be changed under the provision of 10 CFR 50.54p(2).
