CALIFORNIA RECIPROCITY INSPECTION #2007-16 (USNRC LICENSE NUMBER 10-30943-01)

On September 12, 2007, this office conducted an inspection of your operations at Pabco Paper located at 4460 Pacific Boulevard, Vernon, CA 90058 for compliance with the California Code of Regulations, title 17, license commitments, and general radiation safety. We are pleased to inform you that no violations were found during the course of our inspection; however, we have the following comment (discussed with you on September 14, 2007) regarding compliance with the Reciprocity License commitments:

Special Condition 3 of the "Notice of Reciprocal Recognition of License for Use in California" requires that a copy of the California regulations be carried at all times when radioactive material is used in California under reciprocity authorization. Although James Melle, the device user and applications sales engineer, possessed a copy of the California Code of Regulations, title 17, because California has adopted by reference title 10, part 20 of the Code of Federal Regulations (10 CFR 20), a complete copy of the California regulations also includes a copy of 10 CFR 20. Mr. Melle did not have a copy of 10 CFR 20 in his notebook or on his laptop. This was discussed with Mr. Melle during our inspection, at which time he said he would discuss this with you. Additionally, he said he would ensure that this document would be included in the documentation carried during future work in California.



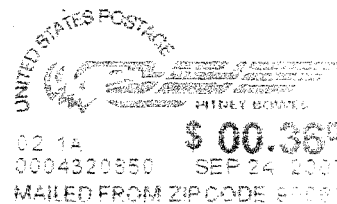
