Subject: Request for Withholding Information from  
Public Disclosure

By your application dated February 22, 1983, and affidavit, you submitted the process control program and plan provided by Hittman Nuclear and Development Corporation (HNDC) for ensuring solidification and dewatering at Watts Bar Nuclear Plant and requested that they be withheld from public disclosure pursuant to 10 CFR 2.790.

Your reasons for requesting our withholding of this information were: (1) that this information was developed at HNDC's expense; (2) that said information released to the public would deny HNDC appropriate use thereof, thereby impairing its competitive position; (3) that said information has been held in confidence by HNDC; and (4) that such information is not available from any other public sources.

We have reviewed your application and the supporting information based on the requirements and criteria of 10 CFR 2.790 and have concluded that you have not provided sufficient justification for us to determine that the information sought to be withheld from public disclosure contains proprietary information. Our records indicate that the information sought to be withheld is already in the public document files since a previous revision to the information was publicly docketed.

Accordingly, we have concluded that the information sought to be withheld from public disclosure does not meet the requirements of 10 CFR 2.790. Therefore, your request to withhold the HNDC process control program and plan for ensuring solidification and dewatering at Watts Bar Nuclear Plant from public disclosure is denied.

In not less than thirty (30) days from the date of this letter, the subject documents will be placed in the Public Document Rooms. If, within thirty (30) days of
