Gentlemen:

As you are aware, 10 CFR 170 of the Commission's regulations for license and inspection fees was revised effective June 20, 1984. Section 170.12(b) of the revised rule provides that for applications for permits, licenses, facility reference design approvals, and special projects which have been on file with the Commission for review for six months or longer, billings would be made at six-month intervals or when the review is completed, whichever is earlier.

Consistent with the requirements of 10 CFR 170.12(b), we have completed the cost analysis for the Natts Bar 1 OL application review for the period June 24, 1984 through December 22, 1984. The cost through that period is \$600,849. The enclosure shows the breakdown of the review costs by program office. When the costs of \$600,849 are added to the costs of \$3,324,761 from the previous period, the cumulative operating license review costs of \$3,925,610 exceed the maximum fee of \$3,077,400 as currently stated in 10 CFR 170.21. Since the fee of \$3,077,400 has been paid, no additional operating license fee is due under 10 CFR 170.21 as revised June 20, 1984.
