SUBJECT: DEFICIENCIES IN TVA PERSONAL SERVICES CONTRACT

This refers to your letter to this office dated August 14, 1984, in which you provided information requested in my letter to TVA dated February 9, 1984. The requested clarification involved previously reported deficiencies pertaining to personal services contracts at Watts Bar and Bellefonte. This matter was previously reported as a significant construction deficiency at Watts Bar and Bellefonte under the following identification: WBRD-50-390/83-25, WBRD-50-391/83-24, BLRD-50-438/83-29, BLRD-50-439/82-24.

Based on our review of this new information, we agree that the additional clarification provided in your revised final report provides adequate documentation of TVA actions and that a suitable basis for closing these deficiencies has been reported. We appreciate your cooperation and the effort expended to provide this additional information.
