

The purpose of this modification is to (1) exercise option period 001, thereby increasing the contract ceiling amount by \$6,729.28 from \$6,729.28 to \$13,458.56 (2) provide funding in the amount \$6,729.28 which increases the obligated amount from \$6,729.28 to \$13,458.56 and (3) extend the duration of contract period to expire on 12/31/2007.

Accordingly, the following changes are hereby made:

1. Refer to Section B.2, entitled, "CONSIDERATION AND OBLIGATION-- COST REIMBURSEMENT (JUN 1988)", paragraphs (a) and (b) are deleted in their entirety and replaced with the following:

"(a) The total estimated cost to the Government for full performance under this contract is \$13,458.56.

(b) The amount obligated by the Government with respect to this contract is \$13,458.56."

2. Refer to Section B.3, "DURATION OF CONTRACT PERIOD (MAR 1987), ALTERNATE 2 MAR 1987", first sentence is deleted in its entirety and replaced with the following:

"This contract shall commence on November 1, 2007 and will expire on December 31, 2007"
