Please refer to our letter dated June 21, 1985 regarding the certification of the Watts Bar unit 1 technical specifications (tech specs).

Included in the referenced transmittal were proposed changes in the reactor trip system interlock allowable values specified in tech spec table 2.2-1. Enclosed is the calculations and data used to support the revised allowable values. The allowable values were calculated consistent with the Westinghouse (\underline{W}) setpoint methodology.

Information regarding the \underline{W} setpoint methodology for Watts Bar Nuclear Plant was provided by our letter dated September 4, 1984 and was noted as being proprietary to \underline{W} . Accordingly, the enclosed information is considered proprietary to \underline{W} and we request that it be withheld from public disclosure in accordance with 10 CFR Section 2.790.


