Reference 1 requested TVA comments on the Los Alamos National Laboratory (LANL) report, "Evaluation of Revised LOTIC-3 Drain-Flow Heat-Transfer Model." Before comments could be provided, TVA requested a meeting (reference 2) to obtain needed clarification on the LANL report. In response to this request, representatives of TVA, NRC, Westinghouse Electric Corporation, and LANL met in Bethesda, Maryland, on November 23, 1987. Reference 3 provided a summary of the information obtained from this meeting and an overall assessment of the issue. Reference 3 also provided TVA's commitment to provide comments on the LANL report by September 15, 1988.

The enclosed Westinghouse addendums to WCAP-10986 (proprietary) and WCAP-10987 (nonproprietary) provide TVA comments on the LANL report. The enclosed WCAPs were written for Watts Bar and Catawba; however, due to design similarities, the methodology of the WCAPs applies to Sequoyah.

Also enclosed is Westinghouse's "Application for Withholding Proprietary Information from Public Disclosure," CAW-88-085, which includes an accompanying affidavit and proprietary information notice from Westinghouse. Because this letter contains information proprietary to Westinghouse, it is supported by an affidavit signed by Westinghouse, the owner of the information. The affidavit sets further the basis on which the information may be withheld from public disclosure by the Commission and addresses with specificity the considerations listed in paragraph (b)(4) of section 2.790 of the Commission's regulations.
