SUBJECT: WATTS BAR NUCLEAR PLANT DETAILED CONTROL ROOM DESIGN REVIEW (TAC NO. 63655)

The Tennessee Valley Authority (TVA) submitted to NRC a Detailed Control Room Design Review (DCRDR) Summary Report for the Watts Bar Nuclear Plant (WBN), Units 1 and 2, on October 2, 1987. During the period of November 11 through 18, 1988, NRC staff and consultants conducted an on-site pre-implementation audit of the WBN DCRDR.

The NRC staff Safety Evaluation (SE) of the WBN DCRDR is enclosed. Attached to the SE is the Technical Evaluation Report of the DCRDR prepared by our consultant, Science Applications International Corporation.

TVA is requested to provide the NRC with a supplemental DCRDR summary report which addresses the issues discussed in Sections 2.2, 2.3, 2.5, 2.7 and 2.8 of the enclosed SE.

Further, we note that TVA plans to correct all Human Engineering Discrepancies (HEDs) for WBN Unit 1 and common systems prior to the initial fuel load of Unit 1. We request that TVA inform NRC in writing of any changes in this commitment, including sufficient justification for delays in implementation beyond the initial fuel load date.

The staff has also reviewed your letter dated March 7, 1989 concerning your request that the Watts Bar SER, Appendix D commitments be superseded by the WBN DCRDR summary report. The staff's position on this matter is that TVA must be able to demonstrate how each of these commitments has been satisfied. This position was also relayed to TVA during our audit in November 1988.
