Enclosed is the Vendor Information CAP Plan that has been revised to provide further discussion of the root causes for the deficiencies associated with vendor information. The Vendor Information CAP Plan has also been revised to clarify the means to confirm plant adequacy and to incorporate changes to the corrective action planned to resolve the deficiency identified in NRC violation 390/87-05-01. A revised response to violation 390/87-05-01 will be provided. Other changes include a restructured basis of the CAP plan (Attachment 1) and the addition of a list of other findings that were initially believed to be related but have been excluded from the program as unrelated (Attachment 2).

Enclosure 2 provides a summary of the commitments contained in this submittal. Commitments contained in the previous revision of the Vendor Information CAP Plan and the June 27, 1989 letter have been superseded or are reflected in TVA's response to Generic Letter 83-28.
