INTERIM REPORT

The subject deficiency was initially reported to NRC Inspector Steve Weiss on December 9, 1985, in accordance with 10 CFR 50.55(e) as Nonconforming Condition Report (NCR) WBN 6463. NCR W-333-P, which identified additional conduit support deficiencies, was later added to the scope of the identified deficiency. TVA's initial response on this issue was submitted as an interim report on January 29, 1986.


TVA has been reviewing civil/seismic issues at WBN, the results of which may influence resolution of this deficiency. A meeting between TVA and NRC is scheduled for August 2, 1990, to discuss the results of this review; therefore, TVA expects to submit a final 50.55(e) report by August 31, 1990, rather than July 31, 1990, as previously committed. Mr. Ken Barr, NRC Region II, was notified of this change on July 27, 1990.


