SUBJECT: SUMMARY OF MEETING WITH TENNESSEE VALLEY AUTHORITY AND VISIT TO THE WATTS BAR NUCLEAR PLANT

A meeting was held with Tennessee Valley Authority on April 25, 1979, and a visit to the Watts Bar Nuclear Plant was made on April 25 and 26, 1979 to acquire information for further development of the fault trees by Sandia Laboratories. During the meeting, Messrs. Cramond and Boyd of Sandia Laboratories presented general information on the development and use of the fault trees for Task A-17 which uses the Watts Bar Nuclear Plant as an exemplary facility. The items of particular interest during the plant visit were the pumps and valves of the reactor coolant system, power conversion system, auxiliary feedwater system, emergency core cooling system, boric acid system, and the chemical and volume control system. Sandia Laboratories will use the information obtained to verify the fault trees and to develop further details in the fault trees. A list of persons who attended the meeting is included as an Enclosure to this summary report.
