

The purpose of this modification is to (1) correct the "Total Contract Ceiling" amount on page 1 of modification no. 7, (2) correct the total estimated cost to the Government for full performance under the contract in modification no. 6, to correct modification no. 2 and (3) obligate incremental funds in the amount of \$10,000. Accordingly, the contract is modified as follows:

1. Refer to **modification no. 7**, page 1, block 14, change to read "Total Contract Ceiling: \$471,732.00."
2. Refer to **modification no. 6**, page 2 of 2, item no. 3; "in modification no. 2 under Section B.3(a), change to read as follows:

The total estimated cost to the Government for full performance under this contract is \$215,546.

3. Section B.3, Consideration and Obligation-Cost Reimbursement (JUN 1988) Alternate I (JUN 1988) paragraph (b) and (c) are deleted in their entirety and the following paragraphs are substituted in lieu thereof:

(b) The amount presently obligated by the Government with respect to this contract is \$339,000.

(c) It is estimated that the amount currently allotted will cover performance through December 5, 2007.

All other terms and conditions of the contract remain unchanged.

A summary of obligations for this contract from the date of award through the date of this action is provided below:

This modification obligates fiscal year funds in the amount of \$10,000.
