PROGRAM SCOPE

This licensee was a private practice physicians group office and authorized to use licensed material permitted by Section 35.200 limited to cardiovascular procedures. The clinic was open M-W-F. The nuclear medicine department was staffed with one full-time technologist who performed approximately 25-45 diagnostic nuclear cardiology procedures per month. The licensee received unit doses from a licensed radiopharmacy. The licensee retained the services of a consulting physicist to perform quarterly audits of the radiation safety program.

This inspection consisted of interviews with licensee personnel, a review of select records, tour of the nuclear medicine department, and independent measurements. The inspector observed licensee personnel prepare, assay and a radiolite unit dosage for cardiac stress testing procedure.
