License Renewal Application for Oyster Creek Generating Plant

On December 18, 2007, the Atomic Safety and Licensing Board (ASLB) issued an initial decision rejecting a challenge by a group of organizations collectively known as "Citizens" to AmerGen's application to renew its operating license for the Oyster Creek Nuclear Generating Station. In the decision, the ASLB ruled that AmerGen has demonstrated that the frequency of its planned ultrasonic measurements, in combination with the other elements of its aging management program, provides reasonable assurance that the sand bed region of the drywell shell will maintain the necessary safety margin during the period of extended operation. A public hearing was conducted in Toms River, NJ on September 24 and 25, 2007 to hear testimony on this matter.

Advisory Committee on Nuclear Waste and Material Briefing

On December 18, 2007, the staff participated in a briefing to the Advisory Committee on Nuclear Waste and Material (ACNW&M) on changes to the Significance Determination Process (SDP) for the Public Dose Cornerstone of the Reactor Oversight Process (ROP). ACNW&M requested this briefing to become familiar with the ROP and changes being made to the Public Dose Cornerstone SDP as a result of SECY-07-0112, "Staff Evaluation and Proposed Revision to the Public Radiation Safety Significance Determination Process to Address Radioactive Liquid Spills and Leaks."

NRC Receives Revision 1 to Calvert Cliffs Nuclear Power Plant, Unit 3 Partial Combined License Application

By letter dated December 14, 2007, UniStar Nuclear provided Revision 1 to the Calvert Cliffs Nuclear Power Plant, Unit 3 partial combined license application. This letter was submitted in response to the eight issues that the NRC staff identified during the acceptance review. The staff will review the information which included revisions to the final safety analysis report chapter 2 and the environmental report to determine if the application has sufficient information to warrant accepting for processing and further review. If the application is found acceptable for docketing, the staff will assign a docket number to the partial application. The second and final part of the combined license application is due to be submitted by the end of March 2008.

Selection of Reference Design for the Berwick Site

On December 18, 2007, Pacific Power and Light (PPL) informed the staff that it has officially chosen the U.S. Evolutionary Power Reactor as their reference design for the Berwick site. PPL signed a contract on December 18, 2007, with UniStar to develop the combined license application for submission later in 2008.

American Geophysical Union Fall Annual Meeting

From December 10-14, 2007, NRC and the Center for Nuclear Waste Regulatory Analyses (Center) staff members attended the American Geophysical Union Fall Annual Meeting. NRC and Center staff presented posters and papers related to the Yucca Mountain Project. NRC staff also conducted recruiting activities at the meeting.

International Atomic Energy Agency, Geological Disposal of Radioactive Waste Meeting

From December 10-14, 2007, NRC staff participated in an International Atomic Energy Agency (IAEA) Consultants Meeting, to assist IAEA review and respond to comments from the Member States, on a "Safety Guide for Geological Disposal of Radioactive Waste." The safety guide provides information useful to regulators and developers of geological disposal sites for radioactive waste.

Louisiana Energy Services Management Meeting

On December 17, 2007, staff members from NMSS and Region II held a semi-annual management meeting with Louisiana Energy Services (LES) staff, in Eunice, New Mexico, to discuss management issues related to the LES uranium enrichment project, in Lea County, New Mexico. Discussions included the status of current licensing and legal actions, security issues, construction plans, design changes, and schedules.

NRC / U.S. Department of Energy Quarterly Management Meeting on Yucca Mountain Project

On December 19, 2007, NRC and U.S. Department of Energy (DOE) staff held a Quarterly Management Meeting, in Las Vegas, Nevada. The meeting focused on: (1) the level of design details that DOE intends to include in a license application for a repository; and (2) quality assurance activities. The public observed the meeting and provided input before the meeting was adjourned.

On December 13, 2007, NRC issued to the Council on Environmental Quality (CEQ) a report on NRC's Fiscal Year 2007 Environmental Impact Statements and Environmental Assessments. This report is submitted annually to the CEQ. All Federal agencies report to the CEQ to ensure consistency in environmental documents and analyses. The NRC routinely and extensively consults with other Federal, State, Tribal and local entities, which pursues the goals of formal Cooperating Agency agreements.

Public Meeting On Nuclear Energy Institute's (NEI) NEI 06-11, "Managing Fatigue at Nuclear Power Reactor Sites"

On December 13, staff from RES and the Office of Nuclear Reactor Regulation held a public meeting to discuss NEI 06-11. This document provides guidance for meeting the requirements of the draft fitness for duty rule, Title 10 of the Code of Federal Regulations Part 26, Subpart I. During the meeting, the staff identified some outstanding issues regarding the risk analysis of structures, systems and components of high safety significance; transition of personnel between outage and operating units; application of outage hours; and performance-based review guidance. Another public meeting is anticipated in early 2008.

Participation in NASA Workshop on Databases and Parameter Estimation Methods

On December 19-20, RES staff participated as invited guests in the National Aeronautics and Space Administration (NASA) workshop at the Goddard Space Flight Center in Maryland. The primary workshop objective was to discuss comments on NASA's draft handbook on databases and parameter estimation methods. The design and implementation of a new generation of risk and reliability data systems was also discussed at the workshop.

Partnership in Preparedness Conference

On December 11-12, NSIR staff and management gave several presentations on various emergency preparedness issues at the Joint Federal Emergency Management Agency (FEMA) - NRC Partnership in Preparedness Conference held at Hilton Head Island, South Carolina. The NRC Deputy Director of Emergency Preparedness made a keynote address to open the session on December 12. Approximately 150 representatives from FEMA, Licensees, and State and local Emergency Managers from the Southeastern United States were present at this meeting. Topics presented included an update on the status of current NRC Headquarters projects including the rulemaking for emergency preparedness (EP) regulations and guidance, Protective Actions Recommendation Study; the Incident Response Outreach efforts to strengthen relationships with State officials during EP Exercises and Security Drill and Exercise program.

Predecisional Enforcement Conference with Materials Testing, Inc.

On December 18, 2007, an open predecisional enforcement conference was held with Materials Testing, Incorporated at the RI office. The conference was held to discuss one apparent repeat violation of 10 CFR 30.34(i) regarding proper storage of gauges identified during an NRC routine inspection completed in September 2007. At the conference, the licensee described their corrective actions, which included hiring a quality control individual to monitor activities at all five of the licensee's locations.

Luminant Generation Company LLC Senior Management Change at Comanche Peak Steam Electric Station

On December 17, Luminant Generation Company LLC announced the resignation of Mr. Mark Kanavos, Plant Manager of Comanche Peak Steam Electric Station (CPSES). Mr. Dave Kross, formerly the CPSES Operations Manager, has been selected as the Plant Manager, replacing Mr. Kanavos.

Palo Verde Nuclear Generating Station Special Inspection Public Exit Meeting

On December 19, the staff conducted a public exit meeting at the Palo Verde Nuclear Generating Station Energy Information Center with representatives of Arizona Public Service Company to present the results of the 95003 team inspection. Following the exit meeting, a second public meeting was conducted during which the licensee provided details of their performance improvement plan. There were approximately 120 people in attendance, the vast majority who were Arizona Public Service Company employees. Two members of the Arizona Corporation Commission also attended. The meeting was covered by two print media reporters from local newspapers.

Public Meeting with Omaha Public Power District

On December 20, the staff met with representatives of Omaha Public Power District in the Region IV office to discuss performance at Fort Calhoun Station and the status of the station's performance improvement plan. Omaha Public Power District representatives also discussed their readiness to support an NRC supplemental inspection (Inspection Procedure 95002) and indicated they would be ready for the inspection in February 2008.
