**CERTIFICATION BY WHITE PINE COUNTY REGARDING
SUPPLEMENTATION OF LSN CERTIFICATION**

On July 6, 2007 the Pre-hearing Application Presiding Officer Board (PAPO) issued the Revised Second Case management Order (Pre-License Application Phase Document Discovery and Dispute Resolution) modifying the monthly supplementation requirement to be reinstated when the DOE recertifies its LSN collection. The DOE recertified its LSN collection on October 29, 2007, and as the official responsible for the administration of the White Pine County's duty to duly supplement the White Pine County collection of electronic files of documentary material, I hereby certify pursuant to procedures established under 10 C.F.R. § 2.1009(a)(2), and the Pre-Application Presiding Officer Board's order dated July 6, 2007, to the best of my knowledge, documentary material specified in 10 C.F.R. § 2.1003 has been identified and made available in accordance with the requirements of 10 C.F.R. § 2.1011(b)(2).

This certification covers documentary material identified and made available via the LSN subsequent to White Pine County's initial LSN certification dated February 28, 2007.

At this time White Pine County does not have primary or secondary privilege claims and therefore no logs to submit with the duty to supplement. Nor do we have any redactions to our current LSN document collection.
