Just to ensure completeness and accuracy, I need to get some additional clarification from you.

On April 16, 2007, you issued a memo to the RA that in two places specifically noted the Exponent Report was 757 pages long (ADAMS Accession No. ML071100234). My search of ADAMS only shows 661 pages associated with the Exponent Report.

Are there 94 pages missing, and if so, can I get a copy?

Additional comment regarding ADAMS: While the letter transmitting the Exponent's Head Wastage Report from FENOC to the NRC was dated 3/20/07, one section of the report was entered with a date of 12/15/06 (the date on the cover sheet of the report), and the other 18 sections of the report were entered with a date of 3/15/07 (I don't know how this date was determined). This makes it difficult to find the report. As a miniumum, can all of the report sections have the same date?

Another observation, the CD from FENOC contained an additional file with a single page numbered 8-32A, which shows Figure 8.13. This figure is referenced in the report on page 8-18, but apparently was excluded by mistake. This may need to be added to ADAMS for completeness.
