The purpose of this modification is to (1) provide incremental funding in the amount of \$41,857, thereby increasing the obligated amount of the order from \$803,090 to \$844,947.


Accordingly, the subject task order is modified as follows:

1. The first sentence of paragraph B.2. CONSIDERATION AND OBLIGATION is REVISED to read as follows: "...(b) The amount presently obligated with respect to this task order is \$844,947.00..."

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED, INCLUDING THE CEILING AMOUNT OF \$923,762.15.

This modification obligates FY2008 funds in the amount of \$41,857.
