Pursuant to the Atomic Energy Act of 1954 and Section 40.21 of the Code of Federal Regulations, Title 10 - Atomic Energy, Chapter 1, Part 40 - Control of Source Material, you are hereby licensed to receive possession of and title to, at the above stated location, one hundred thousand (100,000) pounds of thorium magnesium alloy containing not more than 4% thorium for fabrication.

You are further licensed to transfer and deliver possession of and title to refined source material to any person licensed by the Atomic Energy Commission, within the limits of his license.

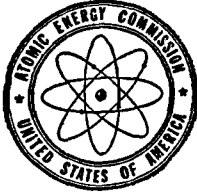
