REMARKS:

IMC 2201 App A (Security Baseline Inspection Program) has been revised to reflect the removal of IP 71130.06 from the Security Baseline Inspection Program.

IMC 1245 (Qualification Program for The Office of Nuclear Reactor Regulation Programs) has been revised to add guidance on: (1) who is qualified to approve signature cards and (2) requirements for refresher training.

IMC 1245 App A (Basic-Level Training and Qualification Journal) has been revised to add training on performance indicators and to update various references and training activities.

IMC 1245 App B (General Proficiency-Level Training and Qualification Journal) has been revised to update references.

IMC 1245 App C-1 (Reactor Operations Inspector Technical Proficiency Training and Qualification Journal) has been revised to update fire protection training; add the course, Root Cause Report Evaluation (G-204), as a post qualification training requirement; update reference lists; and incorporate minor editorial changes.

IMC 1245 App C-2 (Reactor Engineering Inspector Technical Proficiency Training and Qualification Journal) has been revised to update training for Engineering Individual Study Guide ISA-ENG-1 and Engineering On-the-Job Activity OJT-ENG-1 to reflect the new Component Design Bases inspection approach.

IMC 1245 App C-8 (Vendor Inspector Technical Proficiency Training and Qualification Journal) has been revised extensively to update the document's content and format.

IP 71122.01 (Radioactive Gaseous and Liquid Effluent Treatment and Monitoring Systems) has been revised to incorporate updates based on the Liquid Radioactive Release Lessons Learned Task Force report and to provide additional clarifications and inspection items.

IP 92702 (Followup on Traditional Enforcement Actions Including Violations, Deviations, Confirmatory Action Letters, Confirmatory Orders, and Alternative Dispute Resolution Confirmatory Orders) has been revised to resolve ROP Feedback Forms regarding: (1) followup for traditional enforcement and Alternative Dispute Resolution (ADR) Confirmatory Orders and (2) the interface with security inspection program, IMC 2201.

IMC 2515 App C (Special and Infrequently Performed Inspections) has been revised to add IP 92702 to the list of Special and Infrequently Performed Inspections.

IP 71152 (Identification and Resolution Of Problems) has been revised to address a ROP Feedback Form and incorporate enhancements identified by the Problem Identification and Resolution Best Practices draft report.
