You requested authorization for Dr. Christopher Ladner, Ph.D., for materials permitted under 10 CFR 35.100, 35.200, and oral administration of sodium iodide iodine-131 for imaging and localization studies and treatment of hyperthyroidism and cardiac dysfunction.

As discussed over the telephone, due to changes in NRC regulations, the ABR certification submitted for Dr. Ladner is not recognized by the NRC under 10 CFR Part 35. Beginning in June 2006, ABR certificate in Diagnostic Radiology is acceptable only if "AU eligible" appears above the ABR seal.

A representative from ABR stated that Dr. Ladner's certificate is missing the "AU eligible" because he failed to submit the required documentation. Dr. Ladner can enroll in a course given by ABR and once Dr. Ladner passes the course, ABR will reissue his certificate with the "AU eligible" above the ABR seal. Alternatively, the licensee may choose to resubmit Form 313A (AUD) (please fill out sections 3a and 3b on pages 2-3, demonstrating that the number of hours in classroom/lab training plus supervised work experience totalled 700 and included at least 80 classroom/lab, and all listed elements were included in the training) detailing Dr. Ladner's T&E and have it signed by a preceptor with the same authorization as requested (page 4, "Part II Preceptor Attestation").

For oral administration of sodium iodide iodine-131 for imaging and localization studies and treatment of hyperthyroidism and cardiac dysfunction, the licensee may submit Form 313A (AUT) detailing Dr. Ladner's T&E and have it signed by a preceptor with the same authorization as requested for Dr. Ladner (the preceptor would need to complete sections 3a, 3b, and 3c, as well as the 35.392 sections of the attestation).

Please provide this information as soon as possible. Please fax your signed response to 610-337-5269, referencing mail control number 141247. For your convenience, I have attached Form 313A (AUT) and (AUD).

Please note that you may not reply to this letter by return e-mail. Your reply must be in writing by letter or facsimile (610-337-5269). If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your application.
