The purpose of Modification No. 1 is as follows:

1. to correct inadvertent typographical errors cited in the award document (Optional Form 347) dated September 28, 2007, and
2. to revise Subsection C.15, PROJECT OFFICER AUTHORITY, to add Technical Monitors to the contract.

Accordingly, the order is modified as follows:

1. Block 17(b) of the award document (Optional Form 347) dated September 28, 2007 is modified. The following statement cited in Block 17(b) is hereby deleted in its entirety "This is a time and material type order with a ceiling amount of \$230,000."
