FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE (TAC
NOS. MD6561 AND MD6562)

Dear Mr. Blevins:

By letter dated December 13, 2007, Mr. Fred W. Madden, Director, Oversight and Regulatory Affairs, Luminant Generation Company LLC (the licensee), submitted an affidavit, executed by Mr. J. A. Gresham, Manager, Regulatory Compliance and Plant Licensing, for Westinghouse Electric Company LLC (Westinghouse), dated December 11, 2007, requesting that the information designated as proprietary in the response to request for additional information associated with the Technical Specifications revision to reflect cycle-specific safety analysis assumptions regarding adoption of Westinghouse methodologies, be withheld from the public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 390. The response to request for additional information and the Westinghouse letter were Attachment 1 and Enclosure, respectively, to the licensee's letter dated December 13, 2007.

The December 11, 2007, affidavit by Mr. J. A. Gresham stated that the submitted information should be considered exempt from the mandatory public disclosure for the following reasons:

- (a) The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies.
- (c) Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
