Gentlemen:

In compliance with Section 70.51C of 10CFR70, the Martin Marietta Corporation hereby makes application for approval of its procedures for the safeguarding of special nuclear material. In our application for renewal of Special Nuclear Material License No. 53 dated January 28, 1965, we included, as Section V, Part A, a description of our Nuclear Materials Management procedures for the control of special nuclear material at our Middle River, Maryland facilitiés. These procedures, which have been approved by the AEC New York Operations Office as control procedures for SS Station MBL and by the AEC Oak Ridge Operations Office for use in connection with our Supply Agreement, apply not only to the control of special nuclear material but also for safeguarding it against unauthorized use. Although all of Section V, Part A is applicable in presenting the total system and the interplay of various functions and responsibilities, those portions in our application which apply more specifically to the specific divisions of Part 70.22(b)(1) are referenced as follows:
